
ASO MEMORANDUM OF UNDERSTANDING reads:

 - All open, transparent, and bottom-up
- Global policy proposals are submitted in all 5 regions
- Each region follows its own process
- It then gets passed to the NRO for review
- NRO passes it to ASO AC, ASO AC reviews whether processes are followed
- ASO AC requests ICANN board put it to implementation
